Liebs described two sets of process observation questions; at end of meeting, reflect back on whether we met our goals, high point and low point, observing process of meeting and interpersonal communications

Beth volunteers to be the process observer for today (Yay!)

Feedback from board retreat

Do we really need two nights? Next year, make sure Rev. Strauss can stay both nights if we plan to stay two nights. The mountain seems a bit pricey. Last year we had funds to cover half the cost, but did not have that this year.

If we do stay two nights, make sure there are activities on Sunday morning.

Mistakes and Miracles presenters were excellent.

In the reserve account, there are funds for reimbursing board retreat for this year or could be used for next year.

Rev. Strauss' worship was excellent during the board retreat.

Schedule board retreat far in advance so everyone can plan accordingly.

For the mountain, necessary to call and call often to make sure it's planned; emails and voicemails are not as effective.

The mountain will try to get you to commit in December; David waited until the first quarter this year.

Board met in executive session to discuss Rev. Strauss' contract

Liebs moves to approve the contract as discussed Terry seconds
All approve, no abstentions

Noted we missed agenda item about scheduling Joy Borra - 2 hour separate meeting possibility - Sunday August 6 after service 12:30pm to 2:30pm

Educating congregation on Article 2:

Probably around 25 people who attended educational session held at UUCA Saturday June 3, 2023

Received overall positive feedback, Jay did a nice job presenting Since we will be voting on it next year, possibility for additional education Many many many changes were made to Article 2 during General Assembly

Approval of minutes:

David moves to approve minutes; Liebs seconds; all approve, no abstentions **Finance report - Dave Sjoquist:**

- May was a good month, and so far, 2023 has been a good year.
- Revenue in May was \$32,555 above what was projected, and YTD is \$41,027 above projected revenue.
- Expenditures for May were \$1,724 above projected expenditures, but YTD expenditures are \$19,117 under projected YTD expenditures.
- Pledge payments are doing well and we appear to be recovering from the reporting issue that was discovered last month.

Fundraising goal of \$58k remains a concern. We haven't found people to lead that effort for the fall. Rentals seem ok, but some concerns over permitting. Possibility for second week of July to appeal to panel instead of having to hold hearings for the Special Land Use Permit (SLUP).

The way Realm was set up, separate pledge years, pledges and payment schedules don't talk to each other; people set up 2022 schedules but continued to apply payments indefinitely so Realm continued to put those into 2022 instead of 2023. Initially calling each person to tell them the situation, but realized that the system was the problem. Instead, change everything for people by moving money from 2022 to 2023, where it was intended, then email and tell them what we did. We have 8 left as of this morning, should be done before the end of the month. Let stewardship know, pledge campaign that stays open; let people set it and forget it. Give a certain amount with increases set per year.

Dave Sjoquist moves to adopt finance report David Yamashita seconds
All approve, no abstentions

Stewardship - Janel:

First team meeting 2 weeks ago; lots of questions from Elizabeth and Chris, when things happen, where are things located; they invited Janel to a second meeting on July 11th, will also include Bryce. Initially, as we start, want to make sure they have everything they need to be successful. Planning to set up a google drive; they are aware of \$1.1M goal the week before Thanksgiving. Theme will be determined. Started discussion about having a tactical plan for approaching new membership. No need to meet with sub-chairs yet. There's a schedule for when we start reaching out to the other leads. Asking Bryce for a list of new people to call about pledging.

All congregation call - Barbara:

Barbara will take lead and use Lay Ministers, board members, and others. Asking Bryce for a list of people for the congregation-wide calls.

Healthy relations - Beth:

Having new members sign a covenant - what is logistically the best way to do this? Connect with belonging team, Sean and Janet are handling new members Still want to redo covenant; summer is the planning time; listening circles, what do we want to do; they don't have a plan yet, but plan to have one by the end of summer and will be presented to the board

Nominating committee - Barbara:

Met this past Sunday, energetic and positive; they want to be trained more in radical welcome; visibility, they want to be trained and later lead training themselves; open meetings for nominating committee; informational meeting; more personal for the ask; idea for larger nametags for Nominating Committee members so that they are more visible

ARAOMC Committee - Terry:

Reviewed handout of recommendations and proposal for committee name, objective, initiatives; adding initiatives for ARAOMC monitoring; will work towards finding committee members; report out at congregational meetings; next steps will be talking to people about being on the committee, they can figure out their own chair; provide that list to board; asking for help to recruit committee members; recommendation for reaching out to group leaders that were previously contacted asking them for suggestions for committee members; maybe reaching out to Christian Harden about those that joined the book club for Mistakes and Miracles; maybe reaching out to Jason Delaney for those that attended his workshop; previously there was an ARAOMC council after we passed the resolution, they were charged with similar initiatives. Actual actions seemed to be about policing, so people asked to be on the committee felt like they were the ARAOMC police. Before we had a healthy relations committee, when people experienced microagressions or other experiences, people went to ARAOMC council, but now they can go to the Healthy Relations committee. Healthy relations want to be a part and maybe have somebody from ARAOMC committee be on healthy relations. Important distinction that grievances go to healthy relations committee and not to ARAOMC committee.

Endowment Committee - Dave Sjoquist:

Not much happening, added three new members, some good members left; updated their policy and procedures manual; there was a meeting Thursday night of finance group whether to change portfolio to have more socially responsible groups;

approached by someone about the nature of investments. Business resolution that failed at General Assembly to not invest with oil companies.

Fundraising Committee - Liebs:

Still working on putting together group; will talk to David for more information about concert; talk to Rich Hammet about decades dances that Rev. Strauss mentioned; talk to Nicole and their partner; reach out to Derek; check in with Maureen, check in with Lynn Payne on UUMoves about bringing Full Radius in; check in with Susan Pins and Alan Stevenson about hosting/leading chamber music at a house; check in with Bill Porter about contra dancing

Minister Call Committee - Leta:

Still working to put together group; Jim Kelly and Mary Crawley have signed on; plan to talk to Gretchen, Dr. Stringer, Latonya, and Andy Welch; Leta will send virtual radical welcome training to Nominating Committee
